1. Website Operator and definitions in respect thereof

1.1 This website is operated by Konsortium Solutions on behalf of Mobile Therapy (CC) t/a MJ Labs.

1.2 In these Terms:

1.2.1 **“services”** means any functions, facilities, applications, information, or other services available through this website (including, where applicable, ISP (internet service provider and/or internet access) services).

1.3 **“Terms”** mean the terms and conditions as stipulated below.

1.4 **“User”** means any person, whether natural or a person in their official capacity as an authorised agent, organ of an Organisation, such employee or any other unspecified relation who accesses or uses this site, with or without MJ Labs’, or that of their designated agents’ authorisation and whether you are registered to use this or part of this site.

1.5 **“Website”** or **“Site”** means the ‘home page’ and underlying web pages or other collection of information and/or applications operated by Konsortium Solutions and available for access via physically linked or wireless networks (including the internet and networks accessible using wireless application protocol or similar ‘wap’ technology) through access devices such as PCs, laptop computers, mobile telephones, PDA’s, digital cameras, televisions or other network-enabled devices, on which these Terms are posted or which is expressly referred to in connection with User being requested to agree to these Terms.

1.6 Any reference to this website or site includes a reference to any related ‘wap’ site. Certain other terms are defined in the text below.

2. Access and Use of this Website

2.1 By accessing, browsing, or downloading any part of this site or its content, or posting or uploading to this site, or any other use of this site and its content, whether as an unregistered visitor, you agree to comply with these Terms, without modification (which form a contract between you and MJ Labs) and all relevant applicable laws.

2.2 If your access to this site, you are responsible for obtaining the relevant hardware and software equipment and paying all telephone (or other network) charges necessary to access and use this site and the Services. Access to this site or to the Services may be limited to a maximum number of times and/or duration in each period.

Permitted and Prohibited Use of this Website/Site.

5.1 Access to, and use of this site, including viewing, downloading, reproducing, displaying, posting, and publishing shall only be allowable and/or prohibited in accordance with the following terms:

5.3 This applies to use by any means, including electronic, mechanical, photocopying, recording, creation of derivative works or otherwise.

5.4 MJ Labs gives limited, non-transferable, non-exclusive, revocable permission for User to access and make personal, non-commercial use of this site and Site content as a support and communication resource for purposes specified in this site only.

5.4.1 User may electronically copy and print in hard copy Site content for these purposes, provided that all copyright and proprietary notices (where present) are retained on Site content.

 - 5.6.2 User shall not use this site or the Services in a way that breaches these Terms.
 - 5.6.3 or any applicable law or regulations (including those relating to the use of public communications networks) or that causes or is likely to cause any damage, interruption or impairment of this site or the Services.
 - 5.6.4 User may not attempt to gain unauthorised access to any part of this site, other User accounts or any computer systems or networks connected to this site, whether through:
 - 5.1.12.1 hacking,
 - 5.1.12.2 password mining or,
 - 5.1.12.3 any other means.
 - 5.1.13 User may not collect or attempt to collect personal information relating to others through this site.

6. Copyright and Copyright ownership

- 6.1 MJ Labs does not transfer title to any Site content downloaded or used by any User.
- 6.2 Site content, layout and selection remains the intellectual property of MJ Labs, and those respective parts belonging to its agents and/or affiliates remain as such, their respective works.
- 6.3 Limited permission to use 'Site content' (for the purposes stated in the preceding section) is reserved upon the condition that users recognition,



observance and retention of all copyright, trademark and other proprietary notices in Site content, and all proprietary and other intellectual property rights of MJ Labs and/or content and technology providers, in Site content.

- 7.2 All User content will be considered non-confidential, not subject to any use restrictions and no User content will be subject to any obligation of confidence on MJ Labs' part.
- 7.3 This section does not apply to any personal information submitted by a User which identifies him or her. This will be processed only as provided in the personal data section of the data or registration submission form of this website, elsewhere in these Terms and any other terms and conditions which apply specifically to any relevant transaction (if any) between User and MJ Labs.

8. Prohibited User Content

- 8.1 MJ Labs prohibits the transmission, distribution, dissemination, uploading, posting, submission, sharing and storage on, via or through use of this site (together, uploading) of User content which it considers (in its sole discretion) to be inappropriate or distasteful.



8.2 Such User content includes (without limitation):

- 8.2.1 communications with – pornographic, profane, sexist, homophobic, defamatory, deceptive, vulgar, obscene, or offensive content;

- 8.2.6 Price-sensitive information relating to publicly listed securities;
- 8.2.7 Material that could give rise to any civil or criminal liability under any laws;

8.3 MJ Labs prohibits the uploading or use of Site content or transmission of User content with a primary or secondary purpose or effect:

- 8.3.1 To sell, distribute or promote firearms, weapons, or controlled substances;
- 8.3.2 Pyramid or -related schemes, chain letters, fraudulent or otherwise criminal offers;
- 8.3.3 To register another email address other than your own;
- 8.3.4 To distort auctions or other markets (including public quoted securities markets);
- 8.3.5 To threaten or harass others;
- 8.3.6 To disrupt discussions or to create a false identity for the purpose of misleading others;
- 8.3.7 To convey sexual requests from, for or to a minor;
- 8.3.8 To make racial slurs or comments;
- 8.3.9 To impersonate any person or misrepresent your affiliation with any person or entity.

8.4 User shall not advertise or offer to sell or buy any goods or services for any business purpose unless the relevant Forum or Service specifically permits this.



8.5 MJ Labs reserves the right (but does not accept any obligation) to delete or restrict Users' access to relevant Site content and/or User content and/or to pass relevant User content and/or information relating to User (including personal information) to any appropriate authority where User content is uploaded in breach or suspected breach of any of these Terms or any applicable law or regulations, without any requirement for any claim or complaint to be formally commenced or proved.

9. Copyrighted Material and Intellectual Property

9.1 MJ Labs prohibits the uploading of content that contains music, software, images (still or moving), literary or artistic works or other material protected by intellectual property laws (or that may infringe others' intellectual property rights), unless the User owns or controls the exclusive rights thereto or has received all required consents (which the User warrants if such content is uploaded).

9.2 MJ Labs prohibits the uploading of actual or suspected copyrighted materials, the use of which is unauthorised, or counterfeit materials.

10. Personal Information

10.1 Except for personal information of a User submitted by that User for contact purposes or (if applicable) personal information relating to other natural persons known to a User for inclusion in that User's online address book,

10.2 MJ Labs prohibits the uploading of any User content which discloses personal or private information concerning any individual or entity, including, but not limited to:

10.2.1 telephone number(s), e-mail or physical addresses, User account numbers, passwords, and financial information.

10.3 Where personal information relating to, or images of, another natural person are uploaded by a User for inclusion in that User's online address book, photo album (or for any other purpose), the User warrants that such person (the data subject) has given his or her consent to such submission and to the data processing that this involves and any other usage of such User content contemplated by these Terms or on this site.

11. "Spam" Materials

11.1 All forms of 'spam' or junk e-mail, including uploading or sending multiple unsolicited submissions to different discussion groups, mailing lists, and all activities that facilitate spam, are prohibited on or via this site.

Viruses and Materials of a Similar Nature

14.6 MJ Labs makes all reasonable commercial efforts to protect your personal information and privacy.

14.6.1 MJ Labs cannot guarantee the security of any information you disclose online.

14.6.2 The data subject makes such disclosures at their own risk.

14.6.3 Except in relation to personal information submitted by a User for the purposes of contacting MJ Labs, where the organisation makes all reasonable commercial efforts to protect your privacy.

14.6.4 MJ Labs shall not be liable in respect of (and disclaims all liability in relation to) User content submitted to an area of the site designated as (or expected to be) a private, personal or limited access area of the site which becomes available to persons other than the User who submitted the User content.
